Under the 'Billing' tab, the screen reflects: current payment status, plan type, amount due, last payment received, policy status, annual and original premium, payments received and due, payment plan, amount due and next bill due and last bill received.

Transactions Type Descriptions:

- **Installment**: All future payments that have not been billed will be listed as an Installment with the applicable due date
- **Payment:** Once an installment has been paid, the transaction type will change to reflect the payment and the date payment was received
- **Bill:** Once the bill is generated, it becomes a Bill
- Renewal Bill: Forty-five to Sixty days prior to the renewal date, a "Renewal" bill is generated. If the plan type is either a 4-pay or 6-pay, the premium will reflect the amount of the 1st installment. Once the first installment is paid, all remaining installments will populate the screen. This will provide a schedule of payments and due dates

To Calculate the Pay-off Amount: Simply add all **'Bills and Installments**" then subtract all but one **'Billing Fee**" to get the total pay-off amount. The **'Bill To**" field lists the name of the individual/company that the bill is sent to. The **'Pending Status**" field will show if a notice of cancellation has been sent for any of the following reasons: non-payment, underwriting reasons, insured request or a notice of non-renewal.
